- 2. The BC32SN2 First Aid Kit <u>cannot</u> be part of Survival Craft equipment on vessels flying the European flag
- 3. The storage arrangement of the first aid kit is not part of this Design Appraisal or Certificate. All such arrangements are to be to the satisfaction of the Surveyors attending on board
- 4. If the specified standards are amended during the validity of this certificate, this product type is to be re-approved prior to it being supplied to vessels to which the amended standards apply
- 5. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure compliance with SOLAS Regulation III/5. Production records are to be kept as required by MSC.81(70), Paragraph 1.2
- 6. Production tests are to be conducted to ensure compliance with SOLAS Chapter III Regulation 5. This does not preclude any further testing to additional requirements of the Marine Administration of the country where the ship is registered (i.e. the flag state) or those acting on behalf of that Administration
- 7. Should a change of Place of Production from that stated below be required i.e. where the stages of manufacture/assembly/testing of this product take place, the new Placer of Production is to be advised to us prior to the change taking place. This Certificate will require to be updated for Approval to be maintained
